
Creative Corrections was tasked with auditing the Milwaukee County Jail, a facility facing significant issues related to inmate safety, mental health care, and overall operational breakdowns. The audit objective was to evaluate the facility's compliance with legal standards and to identify systemic issues such as staffing deficiencies, inadequate mental health care, and operational failures contributing to preventable incidents.

The audit was extensive, covering critical operational areas such as life safety, suicide prevention, housing conditions, use of force, medical services, and facility maintenance. Over 60 Corrective Action Plans (CAPs) were developed to address identified deficiencies, making it one of the most in-depth and actionable jail audits conducted in the region. With multiple auditors working across various units of the facility, maintaining data accuracy and organization was a significant challenge.

Limited internet access in certain areas further complicated real-time data collection. Creative Corrections needed a solution that could ensure consistent and accurate data entry while managing the complexity of the audit.

"We're sitting here with all these concerns, and people are still dying," said Tiffany Stark, a community activist involved in the process. "We need to figure that out like now. Like, yesterday."

Certainty's offline functionality was a crucial feature that enabled the team to continue working, even in areas with no internet access, ensuring uninterrupted data collection.


